This Amendment No.1 of Annex B1.0.

is valid from: **01 October 2023**
and modifies: **ANNEX B1.0 dated 01 October 2021**
for the locations: **All Hellenic Airports except PAS,SKU,LXS**

PREAMBLE: This Annex B is prepared in accordance with the simplified procedure whereby the Carrier and the Handling Company agree that the terms of the Main Agreement and Annex A of the SGHA of January 2013 as published by the International Air Transport Association shall apply as if such terms were repeated here in full. By signing this Annex B, the parties confirm that they are familiar with the aforementioned Main Agreement and Annex A.



The Parties agree herein to make the following modifications of the above Annex B1.0:

PARAGRAPH 1 – HANDLING SERVICES AND CHARGES

1.2 Services (as per Appendix 1)


1.3 Charges: BASIC HANDLING CHARGES IN EURO FOR VALID HAAF (ELAO) MEMBERS

PARAGRAPH 7 – DURATION MODIFICATION & TERMINATION

- 7.1 Notwithstanding Sub-Articles 11.4 and 11.5 of the Main Agreement, this Agreement shall be maintained in force from **01 October 2023** until **30 September 2025** and shall continue in force until terminated by either Party, giving sixty (60) days prior written notice to the other Party.
- 7.2 Yearly Price Revision:
The charges set forth in paragraph 1.2 of the Agreement represent the year of 2023 economic conditions and are subject to an annual price adjustment by the Handling Company starting from 01 October 2024 and for any subsequent year this Agreement remains into force. Such price adjustment shall be based on the country's (Greece) average cost price index (CPI). The copy of the official publication source contained mentioned information with economic indicators must be provided to the Carrier preliminary. The Handling Company informs the Carrier about such adjustment as minimum 60 calendar days before to come into force.
- 7.3 Any modifications of this Annex B may only be made in writing and by mutual agreement of the parties.

All other terms and conditions of the Annex B1.0 signed between the Parties on **01 October 2021** and as amended with the present Amendment No.1 continue to apply and are in full force and effect.
